In light of FINA's ruling regarding the legality of the 2009 nero swimskin we are happy to offer to you the nero Buy Back Program.

Customers that meet the criteria listed below may return their suit in exchange for a new, FINA approved 2010 neroTX swimskin at 50% of the retail price.

### REQUIREMENTS:

Customers who purchased a blueseventy nero swimskin between the dates of April 1, 2009 and November 1, 2009 are eligible for participation in the program.

### PARTICIPATION:

Customers who purchased a nero swimskin within the time period listed above and wish to participate in the program may send the original nero swimskin along with proof of purchase to blueseventy at the address listed below.

Proof of purchase may be any of the following:

- Invoice from blueseventy
- Receipt from the retail location the suit was purchased
- Debit or Credit Card statement showing the transaction (other line items may be blacked out for your privacy)

The attached form, suit, proof of purchase, and payment are to be sent directly to blueseventy. Buyback requests will be accepted between the dates of February 15 and March 15, 2010. Any product received before or after those dates will be returned to sender. Buyback requests will be filled in the order that they are received and shipped based on limited availability.
